We would like to encourage you to emphasize the importance of a commitment to human rights at all levels in own operations by conducting human rights due diligence process to identify and assess human rights risks as well as define mitigation actions, grievance mechanisms and remediation actions to respond to human rights violations, monitor and report related human rights indicators to relevant parties and also encourage your stakeholders to respect human rights. We are ready to support your efforts and would like to express our appreciation for your shared commitment and for the vital role your company plays in respecting human rights in your operations.
