

Product Stewardship Policy

SCG Packaging Public Company Limited (SCGP) committed to be a leading multinational consumer packaging solutions provider through innovative and sustainable offerings. SCGP gives important to the responsibility of products, services and solutions (Product Stewardship), which complies with the rules to protect and promote safe and environmentally friendly products, services and solutions by assessing Life Cycle of products, starting from the design, acquisition of raw materials, transportation of raw materials, production, transportation of goods and services, use phase until recycling and end of life of products. Product Stewardship is part of SCGP's operational strategy.

The policy outlined herewith shall be applied to all production operations, business facilities, business partner in value chain and joint venture: from designing, procuring, manufacturing of products, services and solutions, distribution and logistics, and managing of our wastes and end of used products. This policy shall also be applied to suppliers, contractors and service providers (tier 1 and non-tier 1); other key business partners such as associate companies (non-managed operations), joint venture partners, outsourcing partners, new project, modification project, due diligence of mergers and partnership of SCGP both domestic and abroad with the following:

- 1. Consider policies, strategies, and operational guidelines for responsibility of product, services, and solutions, which are aligned with law, regulation and standard, both nationally and internationally.
- 2. Set development plan and design criteria of product stewardship for high quality, safety and aligned with laws, regulations and standards of product stewardship, both domestically and internationally.
- 3. Analyze and assess the risks, opportunities and impacts of product stewardship, such as the impact from the use of raw materials and chemicals containing hazardous substances, including the risks from the use of conflict minerals.
- 4. Implementation of product stewardship through life cycle aligned with Circular Economy Principle as follow.
 - Upstream designing environmentally friendly and safety product, services and solutions by selecting recycled raw materials, reducing resources and energy use all of life cycle, avoiding the chemicals use that are harmful or have an impact on the environment, planning to be safe raw materials distribution, storage and transportation and reducing the number of transportation trips, including reducing pollutions emitted to environment.
 - Operation production processes implementation which consider using efficiency resource, using renewable energy, reducing water consumption, increasing water recycle proportion, reducing waste generation, increasing reuse and recycling waste, converting waste to

value, reducing energy consumption, reducing Greenhouse Gas (GHG) emissions and

reducing air pollution, which are aligned with 3Rs (Reduce, Reuse, Recycle), and improving

the production process to be more efficient.

Downstream - Designing products, services and solutions for product distribution, storage

and transportation, use phase and end-of-life management of products by providing better

efficiency and energy/water/material savings, prolonging lifetime, increasing durability

reusable or recyclable products, reducing impacts on environment, reducing waste to

landfill, increasing reuse and recycle content, including increasing safety of every process.

5. Support resources for product stewardship implementation such as specialists for Life Cycle

Assessment (LCA), product design knowledge, research and development, procurement of raw

materials and chemicals that are environmentally friendly and safe, allocate budgets and

technologies to improve the production process to be sustainable.

6. Check, monitor, assess and review product stewardship execution. Along with developing and

improving various processes to be more efficient.

7. Consider and select suppliers and contractors who implement aligned with SCGP's product

stewardship policy.

8. Provide adequate training and knowledge sharing to employees and stakeholders in understanding

of product development and improvement principles, including increase impacts realization as part

of product stewardship.

9. Enhance, support and collaborate with stakeholder through value chain such as government

agencies, private agencies and others related agencies to drive product stewardship execution.

10. Be open, transparent and accountable to our stakeholders regarding our product stewardship

performances, impacts and regularly reporting.

11. Announce and deploy this policy through appropriate measures to raise awareness on product

stewardship among employees, customers, suppliers, contractors and others related stakeholders.

To ensure that this Product Stewardship policy is embedded in our organizational culture and put into

action, all companies shall adapt this policy to suit their business according to SCGP Vision.
